

RPR SMOOTH & GLOSS KERATIN TREATMENT

INSTRUCTIONS & PRECAUTIONS



PROFESSIONAL USE ONLY. DO NOT USE IT AT HOME. Do not self-apply this product.

ATTENTION: Apply a protective cream around the hair line and ears to avoid irritation on sensitive skin.

INSTRUCTIONS


1. Wash hair twice with Purifying Shampoo – Step 1.
2. Dry hair 100%
3. Divide hair into 4 sections. Before use, SHAKE Treatment well.
4. Apply RPR SMOOTH & GLOSS KERATIN TREATMENT Step 2 section by section. Wear gloves. Start from the nape in fine sections. Using spray bottle, apply 0.5 -1cm from roots. Comb each section with a fine-tooth comb for an even distribution. Take backward sections at sides and top to avoid contact with face.
5. Process according to HAIR TYPE table guide below.

HAIR TYPE	HAIR LENGTH	PRODUCT AMOUNT	PROCESSING TIME
1A – 1B – 2A	Short to Medium	70 – 100ml	30 – 40 minutes
1A – 1B – 2A	Long and Thick	100 – 150ml	30 – 40 minutes
2B – 2C – 3A	Short to Medium	70 – 100ml	40 – 60 minutes
2B – 2C – 3A	Long and Thick	100 – 150ml	40 – 60 minutes
3B – 3C	Short to Medium	70 – 100ml	40 – 60 minutes
4A – 4B	Long and Thick	100 – 150ml	40 – 60 minutes

6. Blow dry the hair smooth with a round brush.
7. Working with ¼ inch sections (approx. 5mm), pass a flat iron:
 - 4-5 times for hair type 1A-1B and 2A-2B-2C.
 - 6 – 8 times for hair types 3A-3B-3C 4A-4B-4C.

Use the following temperatures below:
 Normal Hair: 220-240 °C
 Fragile, bleached or dyed hair: 180 - 200°C
8. Rinse thoroughly till all product is removed from the hair. We recommend applying AMIPLEX FORTIFY 2, RPR REJUVENATE MY HAIR MASK or SO INTENSE MASK and let sit for 10 minutes. Rinse well. Style as usual.
9. Frizz will be reduced by up to 80% depending on hair type.

GENERAL TIPS:

- Durability: 2-3 months, depending on the hair type and after care.
- Treatment time: 1.5 to 2 hours, depending on hair type and length/volume.
- Is the procedure intended for any type of hair? Yes, except for damaged hair. The condition, elasticity and porosity of the hair should always be evaluated before treatment. Every type of hair will produce a unique kind of straightening result. Extremely curly hair has less cuticles, which means the product has less space to be absorbed, making it difficult to achieve a 100% straight.
- How often should RPR SMOOTH & GLOSS treatment be applied? Our product is a progressive treatment; therefore, it is cumulative. Before reapplying, note the level of straightening and volume reduction achieved along the length and the ends of the hair. In case of a non-satisfactory result, repeat the process, following the instructions, after 15 days. The standard interval between treatments is 2 months, depending on client's hair type.
- Can the treatment be applied to a woman who is pregnant? Yes. As there is no formaldehyde or harsh chemical present in the product. For any concerns we suggest the client show the ingredients to the doctor.
- Can the treatment be applied to a breast-feeding mother? Yes. As there is no formaldehyde or harsh chemical present in the product it. For any concerns we suggest the client show the ingredients to the doctor.

COLOURING:

If colour fade occurs after treatment, it is possible to perform a Demi Colour using 1.5% - 5 vol. However, this may cause a 10% reduction in the final result.

- A demi colour can be performed only after step 8
- AMIPLEX 2 FORTIFY BLONDE TONING, SO COOL Conditioner, SO BLONDE Toning Treatment or RPR BRIGHTEN MY BLONDE Treatment can be used for mild blonde toning.

Regular colouring can be performed 2 weeks after treatment as this allows the hair to return to its natural PH level. High volume colouring and bleaching will reduce the longevity of the Smoothing treatment.

IMPORTANT MAINTAINANCE:

** It is vital to use SULPHATE FREE shampoo & products after the treatment. RPR recommends AMIPLEX Home Care system.

We recommend AMIPLEX and SALON ONLY ranges as they are high quality sulphate free products and ensure optimum results and longevity.

PRECAUTIONS:

- For external use only.
- Follow the instructions and precautions carefully before using. Do not ingest or inhale. Apply in well ventilated area. Avoid contact with eyes and skin. Rinse off immediately if product comes in contact with them and seek medical advice if needed. Always use gloves to apply the product.
- Before using this product refer to dermatologist if you are under any treatment which could affect the skin or if you think you may have a dermatological problem. Do not use if the scalp is irritated or if you suffer of any allergic problem.
- Before each use, carry out a test in a strand of hair following the directions of use. If no adverse skin reaction or hair problem is detected within 24 hours, then you may continue with use. This product contains substances which may cause skin irritation.
- Apply 0.5 cm - 1 cm away from the hair root to avoid touching the scalp. If you feel a strong itching, stinging or tingling sensation during use, remove the product immediately and rinse with plenty of water. If the sensation continues, seek medical advice.
- Do not apply on hair if previously relaxed metallic salts.
- Never exceed the total application time of 60 minutes. Never use / mix with other products except the products recommended by the manufacturer.
- Shake well before use.
- Attention when applying on white hair, it may fade.
